### **Background**

*Yatra Capital Limited (YCL) is a limited liability company incorporated in Jersey on 26 May 2006. The entire capital of the company, net of expenses and after providing for ongoing and future expenses, has been invested by way of subscription in Shares of K2 Property Limited (K2), its wholly owned subsidiary.*

*K2 Property Limited is incorporated on 19 May 2006 in Mauritius as a public company limited by shares with limited life, having its registered office at Suite 2004, Level 2, Alexander House, 33, Cybercity, Ebene, Mauritius. The principal business of K2 is to make investments directly or through subsidiaries in real estate projects in India. K2 has established a number of intermediary holding companies and investee companies in Mauritius for the purpose of holding investments in Indian Portfolio companies (IPCs). K2 and its subsidiaries invest in the shares of real estate development companies referred to as Indian Portfolio Companies*
